# 2nd Roundtable of Wetland City Mayors

Amiens City, France 8-10 June 2023

## **Summary Report**

#### 1. Introduction

Resolution XII.10, adopted during the Ramsar Conference of the Parties in 2015 (COP12), endorsed the establishment of a Wetland City accreditation system, "Wetland City Accreditation of the Ramsar Convention". Under this resolution, Contracting Parties recognize "the huge potential of urban areas in terms of education and public awareness related to wetlands conservation" and that the accreditation scheme "can assist cities, Contracting Parties and stakeholders in promoting awareness on the wise use and conservation of wetlands". This accreditation scheme grants branding opportunities for cities that maintain a strong and positive relationship with wetlands. It will also accord cities with global recognition as model cities, which can also help boost local ecotourism activities.

At Ramsar COP13 held in October 2018 in Dubai, 18 cities from seven (7) countries were officially recognized as "Wetland Cities" under the Ramsar Convention. In support of this achievement, the Ramsar Regional Center – East Asia (RRC-EA) volunteered to assist in forging a stronger network of Wetland Cities by organizing the first Mayors' Roundtable in the fourth quarter of 2019. This roundtable symbolized the first step towards establishing such a network. During Ramsar COP14 in Wuhan, China/Geneva, Switzerland, a new round of accreditation recognized 25 local governments from 13 countries as Wetland Cities. These new Wetland Cities joined the total list of 43 globally accredited local governments with strong advocacy for wetlands from 17 countries.

Against this backdrop, following the first Mayors' Roundtable, the Ramsar Regional Center – East Asia (RRC-EA) and Amiens City Government organized the 2<sup>nd</sup> Roundtable of Wetland City Mayors that was held on 8-10 June 2023 in Amiens, France.

#### 2. Objectives

The roundtable of Wetland City Mayors allows members of the Wetland City Network to meet on an annual basis. The meeting serves as a platform for Wetland Cities to:

- establish and strengthen communication channels among Wetland Cities;
- share and exchange information about experiences in managing urban wetlands with respect to local policies and regulations;
- facilitate dialogues to promote and develop socio-economic and environmental cooperation among Wetland Cities;
- invite and welcome new Wetland Cities to the Wetland City Network;
- introduce the Wetland City Accreditation scheme to potential Wetland Cities; and
- involve International Organization Partners (IOPs) of the Convention on Wetlands and other wetland stakeholders in activities of the Wetland City Network.

#### 3. Participants

More than 130 representatives from Wetland Cities, local communities, academic and research institutions, and government and non-government organizations participated in the event. These included the mayors, vice mayors and officials of 22 Wetland Cities from nine (9) countries in America

(Canada), Africa (Tunisia), Asia (China, Iran, Iraq, Japan, and Republic of Korea) and Europe (France and Hungary). The list of participants is attached as Annex 1.

#### 4. Dates and venue

The meeting was held on 8-10 June 2023 at the Le Quai de l'Innovation, Amiens City, France.

#### 5. Program of activities

#### Opening program

The event started with opening remarks delivered by Mrs. Brigitte Foure, Mayor of Amiens City, who welcomed the Wetland Cities' delegations and other attendees. Messages were also conveyed by Mr. Seung Oh Suh, Executive Director, Ramsar Regional Center – East Asia/Wetland City Network Secretariat; Mr. Jay Aldous, Deputy Secretary General, Ramsar Convention on Wetlands; Mr. Kwan-kyu Roh, Mayor, Suncheon City, Republic of Korea (incumbent Chair of the Wetland City Network); Mr. Stephane Haussoulier, President, Departmental Council of the Somme, France; and Ms. Flore Lafaye de Micheaux, Representative of the French State.

#### Keynote and special presentations

Keynote and special presentations were delivered during the first and second day by speakers from Amiens City, Department Council of the Somme, University of Vienna, Ministry of Environment of the Republic of Korea, RM Wetlands & Environment Ltd./Society for Wetland Scientists Professional Certification Program, and Amiens Energies. Time was also allocated for international organizations such as the Wildfowl & Wetlands Trust (WWT), World Wide Fund for Nature (WWF), United Nations Environment Programme (UNEP), ICLEI - Local Governments for Sustainability, and UNESCO to introduce their various programs.

#### Parallel sessions

The three-day event included two parallel sessions during which mayors and representatives of Wetland Cities had the opportunity to showcase their initiatives on wetland conservation and management. The complete list of speakers and topics can be found in Annex 3.

#### Meeting proper

On the second day, as a segment of the roundtable, mayors and representatives of Wetland Cities convened to deliberate on topics as enumerated in the meeting agenda (Annex 4). Agenda items, salient discussion points, and relevant actions taken are reported in Item 6 of this report.

#### Closing program

As the representative of the host city, Mayor Foure handed over tokens to the heads of delegation of participating Wetland Cities as a gesture of appreciation. After the ceremony, Vice Mayor Liang of Dongying City formally invited all participants to join the third Mayors' Roundtable that is scheduled to take place in 2024 in Dongying, China. Vice Mayor Florence Rodinger of Amiens City delivered the closing remarks to officially conclude the event.

#### Field visit

Amiens City organized a trip to Baie de Somme Ramsar Site, the largest natural estuary in northern France.

Report on accomplishments of the Wetland City Network for the period: 2019-2022	<ul> <li>The Wetland City Network Secretariat reported on the accomplishments of the Wetland City Network for the period 2019-2022, while acknowledging the impact of the COVID-19 pandemic that hampered efforts to implement planned network activities. Despite this challenge, the Wetland City Network Secretariat was able to accomplish the following: <ul> <li>adoption of the logo for the Wetland City Network</li> <li>distribution of brass plates and pins to visually identify Wetland Cities that are members of the network</li> <li>development of the Wetland City Network website</li> <li>conduct of an online technical level meeting to discuss preparations for the 2<sup>nd</sup> Mayors' Roundtable</li> <li>adoption of a new resolution during Ramsar COP14 to provide further clarity on the accreditation/renewal process</li> <li>holding of a side event during Ramsar COP14 to provide a spotlight on new Wetland Cities</li> </ul> </li> </ul>
<ol> <li>Terms of Reference of Wetland City Network</li> </ol>	The Wetland City Network Secretariat facilitated the review of the Terms of Reference (TOR) of the Wetland City Network. After thorough discussions, the meeting noted recommendations to improve the TOR. The TOR will be revised by the Secretariat and subsequently circulated to the network members for approval (see Annex 5).
<ol> <li>Draft Wetland City Network Strategic Plan 2022-2028</li> </ol>	The Wetland City Network Members for approval (see 7 linex 5). City Network Strategic Plan 2022-2028 for further review by the members. The meeting noted the suggestions made by the members.

	The Secretariat will revise the draft Strategic Plan and circulate the amended version to the network members for approval (see Annex 6).
8. Ramsar COP14, Resolution XIV.11: Wetland education in the formal education sector	The Ministry of Environment of the Republic of Korea introduced Resolution XIV.11 on Wetland Education in the Formal Education Sector, highlighting the key points of the resolution and elaborating on the importance of wetland education.
	Subsequently, the Wetland City Network Secretariat informed the meeting about the Wetland School Network, that is already active in China and the Republic of Korea, and invited Wetland Cities to join the Wetland School Network and promote wetland education in their respective localities.
9. Other matters	Youth Forum Initiative (proposed by Jeju City, Republic of Korea) The mayor of Jeju City, Republic of Korea, delivered a short speech to promote the Youth Forum that will be organized in Jeju Island in May/June 2024. The forum aims to gather youth groups from Wetland Cities to discuss innovative conservation strategies and promote discussion on sustainable use of wetlands. On this point, the meeting noted that there are already existing initiatives involving youth on wetland topics, and that it is recommended to learn more about such initiatives and explore opportunities for collaboration.
	Briefing on the Fifth Strategic Plan of the Convention on Wetlands The technical expert of the Convention on Wetlands Secretariat informed the meeting that the process of developing the Fifth Strategic Plan of the Convention on Wetlands is underway. Along this line, the technical expert invited Wetland Cities to engage in the process by sharing suggestions and ideas to support the new Strategic Plan that is scheduled to be released during COP15.
10.Date and venue of next meeting	As agreed during the 1 <sup>st</sup> Mayors' Roundtable, the third meeting will be hosted by Dongying, China in 2024. Upon deliberation by network members, the meeting agreed that Tata, Hungary will host the fourth meeting in 2025. Specific meeting schedules will be decided and announced by the host cities at later dates.
	The Wetland City Network Secretariat will consult network members on the procedure for selecting the next host of the Mayors' Roundtable to give equal opportunities to other network members that are not physically present in current meetings.
11. Closing message	As the new Chair of the Wetland City Network, Amiens City formally adjourned the meeting.

#### Terms of Reference of the Wetland City Network

#### Purpose

Wetland Cities of the Ramsar Convention on Wetlands provide a huge potential to promote the conservation and wise use of urban and peri-urban wetlands in support of the Ramsar Strategic Plan. The establishment of a network of Wetland Cities aims to contribute to the implementation of the Convention on Wetlands through collective efforts of local governments and communities.

The Wetland City Network will serve as a platform that (1) enables effective communication among Wetland Cities, (2) promotes information exchange on experiences and lessons learned in managing urban and peri-urban wetlands with respect to local policies, (3) facilitates dialogues to develop environmental and socio-economic cooperation among Wetland Cities, and (4) provides access to exchanges of resources among network members.

#### Membership and Composition

Wetland Cities accredited by the Convention on Wetlands may join the network as members.

The Wetland City Network may accept observers, provided that they comply with the following criteria:

- 1. international, national and local level governmental or non-governmental organizations that demonstrate willingness to support the activities of the Wetland City Network;
- 2. cities that are interested in becoming a Wetland City and joining the Wetland City Network;
- 3. formally expresses intent to become an observer of the Wetland City Network; and
- 4. officially registered as observer by the Wetland City Network Secretariat.

#### Secretariat

The Ramsar Regional Center – East Asia will serve as Secretariat of the network. The functions of the Secretariat shall be as follows:

- 1. organize or assist the host city in organizing the regular meetings of Wetland City Mayors;
- 2. maintain close coordination and communication among members;
- 3. facilitate the exchange of information among members;
- 4. coordinate technical and policy discussions among members through specific working groups;
- 5. promote the network via its website and social networking sites, among other forms of media;
- 6. forge camaraderie and partnerships among members, and assist members in developing programs that may provide funding opportunities for the sustainability of the network; and
- 7. invite cities and organizations that are interested to participate in network activities.

#### Operation

- 1. Wetland Cities may strive to actively participate in all network activities.
- 2. Members of the network may meet regularly on an annual basis through the Mayors' Roundtable. The Mayors' Roundtable aims to serve as the main forum for decision-making on priority issues by consensus and may be conducted in person or via hybrid format, subject to the availability of resources of members.

- 3. Network members may also hold virtual technical level meetings, as necessary, in between Mayors' Roundtables.
- 4. Network members may share information and experiences on the development and implementation of wetland-related policies and programs related to conservation, wise use, management, education, among others.

#### **Financial Arrangements**

- 1. Members may participate in activities of the network, including attendance to regular meetings, by utilizing their own resources.
- 2. Members may share financial resources with the Wetland City Network Secretariat or with other members to support the implementation of the Wetland City Network Strategic Plan and of other relevant activities as mutually agreed by the members.

#### **Review of Terms of Reference**

These Terms of Reference will be reviewed by members of the Wetland City Network at least once every three (3) years in accordance with the cycle of the Meeting of the Conference of Contracting Parties to the Convention on Wetlands (Ramsar COP). Any amendments to this Terms of Reference shall require deliberation and approval by the Wetland City Network.



# Wetland City Network Strategic Plan 2022-2028

# Background

Resolution XII.10, adopted during the Convention on Wetlands' Conference of the Contracting Parties in 2015 (COP12), endorsed the establishment of the "Wetland City Accreditation of the Ramsar Convention". Under this resolution, Contracting Parties recognize "the huge potential of urban areas in terms of education and public awareness related to wetlands conservation" and that the accreditation scheme "can assist cities, Contracting Parties and stakeholders in promoting awareness on the wise use and conservation of wetlands". This accreditation scheme grants cities with branding opportunities and global recognition as model cities that maintain a strong and positive relationship with wetlands.

Since COP13, numerous cities have been formally accredited as Wetland Cities. In support of the accreditation scheme, the Ramsar Regional Center – East Asia (RRC-EA) volunteered to assist in forging a stronger network of Wetland Cities by organizing the first Mayors' Roundtable on 23-25 October 2019 in Suncheon City, Republic of Korea. At this roundtable, the Wetland Cities unanimously agreed to establish the "**Wetland City Network**" and assigned the RRC-EA to serve as Secretariat of the Wetland City Network.

# Vision of the Wetland City Network

The vision of the Wetland City Network is that:

## The Network delivers on the wise use and conservation of wetlands for the benefit of nature and current and future generations of citizens

# Purpose of the Wetland City Network

Wetland Cities provide a huge potential to promote and deliver on the wise use of urban and peri-urban wetlands. The establishment of an effective Wetland City Network contributes to the implementation of the Ramsar Convention through the collective efforts of local governments, local communities and other important stakeholders.

The Wetland City Network serves as a platform that:

- 1) Enables effective communication among Wetland Cities;
- 2) Promotes information exchange on experiences and lessons learned in managing urban and peri-urban wetlands with respect to local policies;
- 3) Facilitates dialogues to develop environmental and socio-economic cooperation among Wetland Cities; and
- 4) Provides access to exchanges of resources among network members.

# Strategic Objectives and Targets of the Wetland City Network

Four strategic objectives have been formulated based on the deliberations at the 1<sup>st</sup> Roundtable of the Wetland Cities' Mayors. A fifth strategic objective has been included to ensure that Wetland Cities continually implement wise use approaches and that wetlands are managed, restored and created for the benefit of nature and current and future generations of citizens in the face of threats from climate change, environmental degradation and other emerging issues.

## **Objective 1: Communication**

The collective knowledge and experience of the Network is greater than any one Wetland City. Strong and effective communication among, and beyond, the Network is essential to ensure that Wetland Cities, their citizens and nature benefit.

- Target 1.1: Representatives of all Wetland Cities attend the annual Mayors' Roundtable meetings,
- Target 1.2: The Wetland City Network Secretariat communicates effectively with the Wetland Cities.
- Target 1.3: Wetland Cities and the Wetland City Network Secretariat seek to promote the Wetland City Network through a variety of media and through co-badging with relevant parties and events.

## **Objective 2: Knowledge exchange**

Different Wetland Cities experience different challenges and develop a variety of wetland management solutions. Across the Network, different policy and practical interventions will be developed and implemented. Knowledge exchange among the Wetland City Network and also with other stakeholders will be essential to strengthen wetland wise use and to deliver on the wider obligations under the Convention on Wetlands.

- Target 2.1: Wetland Cities exchange knowledge among the Network through various forms of media, platforms, as well as exchange programs, ad hoc training and other practical approaches.
- Target 2.2:Wetland Cities exchange knowledge with observer cities aspiring to be<br/>accredited under the Convention on Wetlands.
- Target 2.3: Wetland Cities actively engage with two-way knowledge sharing with other stakeholders including *inter alia* the Convention's Secretariat, the Convention's Scientific and Technical Review Panel, Ramsar Regional Initiatives, the Convention's International Organization Partners (IOPs), national and local government and non-governmental organizations, civil society organisations (CSOs), academic institutions, schools and other interested parties.
- Target 2.4: Wetland Cities seek to engage and share knowledge with other international organisations involved in sustainable cities including *inter alia* the Convention on Biological Diversity, UN-Habitat, UNEP and ICLEI.

## **Objective 3: Cooperation**

The Wetland City Network provides a platform for dialogues to develop environmental and socio-economic cooperation. Cooperation can be between two Wetland Cities or among

several Wetland Cities, depending on the objective, and will focus on achieving shared environmental and socio-economic outcomes.

Target 3.1:Wetland Cities actively cooperate among the Network on demonstrable<br/>shared environmental and socio-economic outcomes.

## **Objective 4: Resourcing**

The Wetland City Network and its members will aim to share resources, including human resources, and to mobilize and leverage additional resources within and beyond the Network.

- Target 4.1: Wetland Cities have undertaken sharing of human resources to deliver on wetland wise use.
- Target 4.2: Wetland Cities have worked together to seek and secure additional resources for the implementation of priority programs on wetland wise use.

## **Objective 5: Implementation**

Receiving Wetland City accreditation marks the starting point in a process. Wetland Cities will aspire to continually improve and enhance their wetlands to address environmental degradation, climate change and other emerging issues. Wetland Cities will also aim to implement positive practical and policy-related actions that demonstrate an on-going commitment to wise use principles and to securing the inter-generational benefits that wetlands can provide for citizens.

- Target 5.1:Wetland Cities implement measures to improve their wetlands and continue<br/>to uphold wetland wise use principles as models of good governance.
- Target 5.2:Wetland Cities proactively develop wetland-related policies that contribute<br/>to socially and environmentally sustainable urban and peri-urban wetlands.
- Target 5.3: Wetland Cities ensure the full participation of wetland stakeholders in spatial planning and wetland management.
- Target 5.4: Wetland Cities understand and integrate the multiple values of wetlands into spatial and wetland management planning.
- Target 5.5: Wetland Cities manage, restore and create wetlands to optimise the benefits they provide to citizens.

# **Reporting and review**

The Wetland City Network Strategic Plan covers the period 2022-2028, or the equivalent of two COP cycles. The Wetland Cities are encouraged to report on progress towards the specific Objectives and Targets in advance of the COP. The Wetland City Network Secretariat is encouraged to compile a report for consideration and presentation at the COP to demonstrate implementation of the Strategic Plan.

The Strategic Plan should be reviewed, and updated where appropriate, on a two COPcycle basis to ensure that it is still relevant for the delivery against the Vision.
